## Electronic Device Use Student Contract

*Students must read and sign this Electronic Device Use Student Contract for the use of electronic devices on the Pleasant Grove School campus.*

I, \_\_\_\_\_, the student, agree to the following rules for using any computer on Pleasant Grove School's campus. These rules are meant to keep me safe while online, and to keep electronic devices and the network working smoothly for all staff and students. I acknowledge that use of the school's electronic devices and online resources is a privilege and not a right, and it is expected that my use adheres to the learning goals and directions given to me by teachers and staff. I know that not following these rules will result in loss of the privilege to use electronic devices on campus for a time, and continued disregard for any of these rules will result in permanent loss of privileges.

### I agree to the following electronic device use rules:

1. I will follow all teacher and staff directions and established procedures when electronic devices are being used. This includes carrying devices properly and not eating/drinking when using them.
2. I will use the school's electronic devices for the purpose of education and for working on approved school assignments only. I understand that using them for personal use is not permitted. I will not play electronic games unless authorized by staff.
3. I will only use the school's electronic devices if there is a supervising staff member present. I understand that unsupervised use is not permitted.
4. I will not use another person's system account, email account, or academic program account.
5. I will handle all equipment with care and will not attempt to damage any hardware. This includes:
  - a. Physically damaging the computers, or other electronic devices (ex. Scratching screen, removing keys, etc.)
  - b. Modifying the settings (ex. Changing wallpaper, screen saver, rotating screen images, etc.)
6. I will not hide things that I am doing on electronic devices (ex. Unauthorized open tabs, unauthorized websites, playing unauthorized games etc.)
7. I will not cyberbully others. Cyberbullying includes sending, posting, or sharing negative, harmful, false, or mean content about someone else.
8. I will not participate in any unacceptable use of the school network and computers. I will adhere to the Pleasant Grove School ICT (Information and Communication Technologies) Acceptable Use Agreement signed by all enrolled students and their parents.

### Consequences:

Violation of any of the rules described above may result in disciplinary actions which could include:

Loss of network and device privileges, detention, suspension, criminal charges, financial responsibility for all costs associated with system or device restoration including labor, hardware, software, and restoring data if applicable. **The replacement cost for a student computer is around \$400.00.** Failure to submit payment for replacement costs will result in end of year and graduation activities being revoked.
